Scripture

- 1. Yes / No I believe that the words of the Bible are God's words. That those who wrote the Bible were inspired by God to write each word and that this makes the Bible authoritative in matters of belief and practice in the church. (2 Tim 3:16,17, 2 Peter 1:21)
- Yes / No I believe that all of the Bible points to Christ and that right teaching of the Bible will always include a Christ-centered approach. (Luke 24:25-48; 1 Cor 1:23; 2 Cor 1:20)

God

- 3. Yes / No I believe that God is triune. That he is one God and three persons which are Father, Son and Holy Spirit. That each of these persons is fully God. (Matthew 28:19, 2 Cor 13:14, John 8:58, Acts 5:1-4)
- 4. Yes / No I believe that God created all things both seen and unseen. (Genesis 1, 2)
- 5. Yes / No I believe that humans are created by God in the image of God. (Genesis 1:26,27)

Human Beings

6. Yes / No - I believe that every human being has been created by God and as such should be treated with dignity and respect. (Genesis 1:26,27; 9:5,6; 1 Peter 2:17)

- 7. Yes / No I believe that every human being has been created by God as either male or female and that God's original design for gender identity is that it be consistent with their biological sex. (Genesis 1:26,27; Matthew 19:1-12)
- 8. Yes / No I believe that marriage is intended by God to be between one man and one woman until the death of one of the spouses. (Matthew 19:1-12)
- 9. Yes / No I believe that sexual intercourse is to be experienced only inside the marital relationship of husband and wife. (Exodus 20:14, 1 Cor 6:12-20)
- 10. Yes / No I believe that husbands and wives have been given different roles in marriage. The husband is to lovingly lead his wife and the wife is to submit to her husband. These roles communicate the relationship between Christ and the church. (Ephesians 5:22-33; Colossians 3:18,19; 1 Peter 3:5,6) This biblical principle is never to be used as a way to justify abuse in the home. If a wife experiences abuse or is being forced to disobey her biblical convictions, she is not expected to submit in such a situation and should appeal to church leadership for help.
- 11. Yes / No I believe that because of Adam's sin, all humans are born sinful and worthy of eternal death. (Psalm 51:3-5, Ephesians 2:1-3)

Christ and Salvation

- 12. Yes / No I believe that Jesus is fully God and fully human and that there is no mixture of these two natures. (Isaiah 9:6,7; John 1:1,2, 14; Colossians 1:15,16; Philippians 2:6-11)
- 13. Yes / No I believe that a human's only hope for salvation from sin is Jesus' provision of salvation through his death on the cross. (Acts 4:12, John 14:6)
- 14. Yes / No I believe that Jesus literally rose from the grave and that his resurrection proves that Jesus' atoning work on the cross is sufficient for saving sinners from sin and its effects. (4 Gospels, 1 Corinthians 15)
- 15. Yes / No I believe in the literal return (or second coming) of Jesus who will reverse all of sin's effects and reign over heaven and earth forever. (Matthew 24:29-31; Revelation 21)
- 16. Yes / No I believe that Christ's salvation is accessed by faith alone (in Christ's atoning work) and not through any good work that we perform (baptism, righteous living, etc.). (John 6:28,29; Ephesians 2:1-9)
- 17. Yes / No I believe that without God's gracious intervention, human beings cannot respond to the gospel with saving faith. (John 3:3; Colossians 2:13; Titus 3:5)
- 18. Yes / No I believe that if a person has exercised genuine/saving faith in the work of Christ on the cross, they cannot lose their salvation. (John 10:28,29; Ephesians 1:3-14)
- 19. Yes / No I believe that a person that has exercised genuine/saving faith in the work of Christ on the cross will produce good fruit (transformed character, ministry to others . . .) and will persevere in their faith until death. In other words, if they are

truly justified, they will show the fruit of sanctification and will reach a promised glorification in eternity. (Romans 8:30; 1 John 2:9-11; Galatians 5:16-26)

Holy Spirit

- 20. Yes / No I believe that the Holy Spirit primarily works in the life of an unbeliever to convict them of sin and show them the truth of the gospel. (John 16:8-10; 1 Thess 1:4-6)
- 21. Yes / No I believe that every genuine believer is indwelt by the Holy Spirit upon their conversion and that it is not necessary for a believer to have a subsequent "baptism of the Holy Spirit" after conversion. (1 Cor 6:19; 2 Cor 13:14; 2 Tim 1:14)
- 22. Yes / No I believe that the Holy Spirit can work in the life of a believer in ways that include but are not limited to conviction of sin, unity with other Christians, encouragement, comfort, empowerment for Christlike living, giving of spiritual gifts, giving of divine wisdom, giving of words to speak, and the producing of Christlike character. (John 14-16; Galatians 5:16-24; Romans 8:1-11)

The Church

- 23. Yes / No I believe that every believer should join a local church and use their gifts to build up other believers and participate in the mission of the church. (Matthew 16:13-19, 18:15-20, 28:16-20; Acts 2:42; Romans 12:1-8; 1 Peter 2:1-12; Philippians 1:1)
- 24. Yes / No I believe that a person who has exercised genuine/saving faith in the work of Christ on the cross, should express their belief by being baptized by immersion. (Matthew 28:19; Acts 2:41; Ephesians 4:5)
- 25. Yes / No I believe that baptism symbolizes the gospel we believe, the new believers death to sin and new life in Christ, and the joining of the new believer to the fellowship of the church. (Matthew 28:19, Ephesians 4:5; Romans 6:3; 1 Cor 12:13)
- 26. Yes / No I believe that communion (or Lord's Supper) symbolizes the gospel we believe and is used by God as a means for building up the believer and the local church. (Luke 22:14-20; 1 Cor 11:17-34)
- 27. Yes / No I believe that the three biblically sanctioned offices in the church are members, deacons, and elders. (Philippians 1:1; 1Timothy 3:1-13; Titus 1:5-15)
- 28. Yes / No I believe that members are the highest human authority in the church and should have the right to confirm and/or remove their elders and deacons. (1 Timothy 5:17-25; Ephesians 3:10)
- 29. Yes / No I believe that church members have a biblical mandate to submit to their leaders. (Hebrews 13:17; 1 Timothy 5:17; 1 Peter 5:5)
- 30. Yes / No I believe that every church member should give financially to the church in a way that is proportional, generous, and sacrificial. (Luke 6:32-36; 2 Cor 8:1-15; 1 Timothy 5:17,18)

Pastoral Theology:

- 2) A new member reaches out to you to meet up and in the conversation reveals he doesn't understand why MERCYhouse puts so much emphasis on discipleship groups. What would you say to him to explain our vision for these groups?
- 3) A college kid brings two friends to you to talk more in depth about Jesus. They are confused because of what they've heard in their religion class at Umass, and they want to understand the biblical answer of who Jesus is and what he did. How would you talk with these truth-seekers about Jesus Christ and his work?
- 4) You are counseling an unmarried couple who profess to be Christians. They tell you that they are having sex and believe it's okay because they are "married in their hearts". They also would like to become members of the church. Describe how you would handle this couple, including how you would address the issue of being "married in their hearts"?

- 5) You are praying with folks up front after a Sunday Service and a married man asks you to pray for him in regard to an addiction to pornography that his wife knows nothing about. What would you do and how would you counsel this man?
- 6) A church member confides in you that they experience attraction to the same sex. They want to follow God and his word in this area, but have heard conflicting messages from other Christians about whether or not they should act on these desires. How would you counsel them?
- 7) A group of people are talking after a service on Sunday and wave you over to answer a question that they have been discussing - Why do we pray if God is sovereign over all things?
- 8) A person who is struggling with finances is wondering about what they should be giving to the church offering. They ask you if they should continue tithing or give less or quit giving all together. What would you tell them and what scriptures would you point them to?
- 9) An attendee asks if you think people of other religions go to hell. How would you reply?
- 10) An attendee who is interested in joining the church hears about our church's beliefs regarding the baptism of professing believers by immersion and is wondering why we do baptism this way. How would you answer his inquiry?
